EOS Progress

Joel Swanson, facilitator from EOS Worldwide, provided the Board with an overview of the process in which staff leadership has been engaged since February. EOS stands for Entrepreneurial Operating System and provides concepts and tools for businesses and their employees to execute their vision and to achieve company and personal goals, and has been adapted for non-profit organizations.

Reports

• Lead Pastor Report – Paul

The Board received a written monthly report from Paul who is currently on the Prince of Peace mission trip in Tanzania.

• Finance Director Report – Kienan

Kienan expects total offerings to exceed \$3M on the year. This also lends credibility to the budget forecast for 2024-2025. While we will fall short of our budget forecast for 2023-2024, we

see positive trends with the reversal of the decline in giving. We have exceeded both prior years in terms of total giving.

Books sales, royalties, and funerals have all contributed to the positive variance. Book printing, HOA expenses, supplies and printing are well over budget but we were probably underbudgeted for the year.

The stewardship contract was unbudgeted and was \$26k. Kienan noted it was still worth the expense based on our fall stewardship drive. However, Kienan, Paul and Nina believe they will be comfortable moving forward without GSB Consultants, now that they have learned their tools and tactics.

Motion made and seconded to receive and file the written reports for July submitted by Kienan Mick, Finance Director and Paul Dean, Lead Pastor. Motion passed.

The Board entered closed session at 7:30 pm to discuss a personnel matter and resumed regular session at 7:40 pm.
